To All V.Ships Seafarers and Families

Happy New Year to you all! We all hope that you remain safe and well in 2022.

On 3rd December 2021 I sent a letter to you outlining our Covid-19 mandatory vaccination requirements for all of you joining vessels after 15th February 2022 and this was fully supported by our V.Group Chief Executive Officer René Kofod-Olsen, in his letter to all colleagues sent on 22nd December 2021. René also highlighted the rapid and global impact of the Omicron variant and stressed the need to keep our Covid-19 barriers & safeguards in place.

Our mandatory vaccination requirement is already in place for those of you who work onboard our **Leisure fleet** and **specific Cargo** and **Offshore fleets**. This requirement is presently working well. For other fleets, our present records show that 74% of all seafarers joining vessels are fully vaccinated. I would like to pass my thanks to everyone who have taken the positive step of becoming fully vaccinated against Covid-19.

For everyone on leave, I strongly encourage you to become fully vaccinated before you join your next vessel, and from **15th February 2022 this will be a mandatory requirement**.

In addition, when you are fully vaccinated, you are required to upload the vaccination documents via the *V.Crew Connect* App. I have copied the instructions on page 2 & 3 of this letter and if you have any problems, contact your local crewing team.

How to upload your Completed COVID-19 vaccination certificate via V.Crew Connect

1) If you have not used the V.Crew connect app = Download "V.Crew connect" from your app provider.

UPLOADING YOUR COMPLETED VACCINE CERTIFICATE

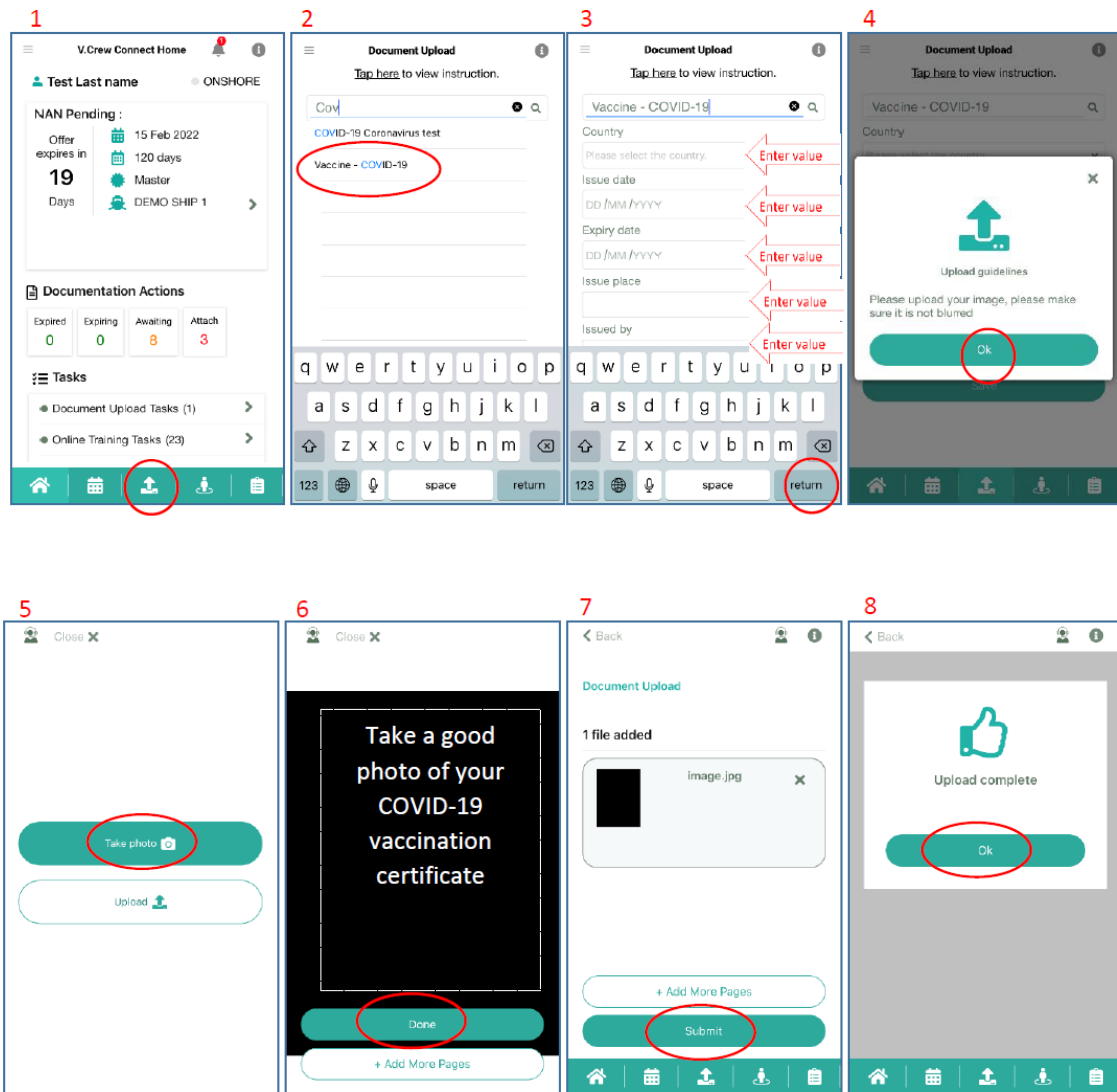
Only upload your COVID certificate when you have completed your vaccinations, i.e. 2

Dose complete or Single dose for Jansen vaccine.

The document relating to the 2nd / Completing Dose is required. Do not upload the document for the 1st Dose, this is not required

When you have logged into the "V.Crew connect" app please follow the below steps:

1. Click on the Upload icon at the bottom of the screen
2. Type in "Covid" word in the document search field and select "Vaccine-COVID-19" document
3. Only enter values into the following cells:
 - 3.1. COUNTRY
 - 3.2. Issue date – this should be marked as the date of your 2nd Dose injection
 - 3.3. Issue Place
4. Click on OK when the Upload Guidance screen appears
5. Click on the Take photo button (optionally you can upload a file from your phone memory)
6. Once a photo is taken, click on Done or choose "Add more Pages" in case the vaccine document has more than one page e.g. each dose is on a separate page
7. Click on Submit button
8. Upload complete message will appear. Click on OK to return to the application home page.

Обращение к морякам V.Ships и их семьям

Поздравляем всех вас с Новым годом! Желаем здоровья и безопасности в 2022 году.

3 декабря 2021 года я направил вам письмо, в котором изложены требования по обязательной вакцинации Covid-19 для всех, кто присоединится к судам после 15 февраля 2022 года. Главный исполнительный директор V.Group Рене Кофод-Ольсеном полностью поддержал это решение в письме ко всем коллегам от 22 декабря 2021 года. Рене также отметил быстрое и глобальное распространение штамма Omicron и подчеркнул необходимость соблюдения всех предпринятых нами мер предосторожности в отношении Covid-19.

Для тех, кто работает на борту круизных судов, грузового и оффшорного флота, уже введено требование об обязательной вакцинации. В настоящее время это требование приносит хорошие результаты. Относительно других флотов, наши текущие данные показывают, что 74% всех моряков, поступающих на суда, полностью вакцинированы. Я хотел бы выразить свою благодарность всем, кто предпринял этот положительный шаг, сделав полную вакцинацию против Covid-19.

Всем, кто находится в отпуске, я настоятельно рекомендую пройти полную вакцинацию до поступления на судно, а с 15 февраля 2022 года это станет обязательным требованием.

Кроме того, когда вы пройдете полную вакцинацию, необходимо обязательно загрузить документы о вакцинации через приложение V.Crew Connect. Я скопировал инструкции на стр. 2 и 3 этого письма. Если у вас возникнут какие-либо вопросы, пожалуйста, свяжитесь с своим офисом.

去年12月3日的一封信，概述了我们对2022年2月15日以后所有上船人员的Covid-19疫苗强制接种要求，我们V. Group首席执行官René Kofod-Olsen在2021年12月22日给所有同事的一封信中对此表示充分支持，同时René还强调了奥密克戎（Omicron）变异毒株的快速传播和全球影响，并强调仍然需要继续保持我们的Covid-19新冠肺炎坚实屏障和保障措施落实到位。

我们的强制性疫苗接种要求已经适用于那些在我们的邮轮船队和特定货物以及海工船队工作的船员和人员。这一要求目前运行良好。对于其他船队，我们目前的记录显示74%加入船只的海员都接种了全剂疫苗。在此向所有采取积极应对并且充分接种Covid-19新冠疫苗的人表示衷心的感谢。

对于所有正在休假的人，我强烈建议您在下一艘船上船之前接种所有针剂疫苗，在2022年2月15日起，这将会是一个强制性要求。

此外，完全接种疫苗后，您需要通过V.Crew Connect App上传疫苗接种文件。该封信的后面第2页及第3页篇章有对于该上传文件的步骤说明详述，当然了，在您遇到任何问题的時候请联系您所在当地的V. Group岸基工作人员。

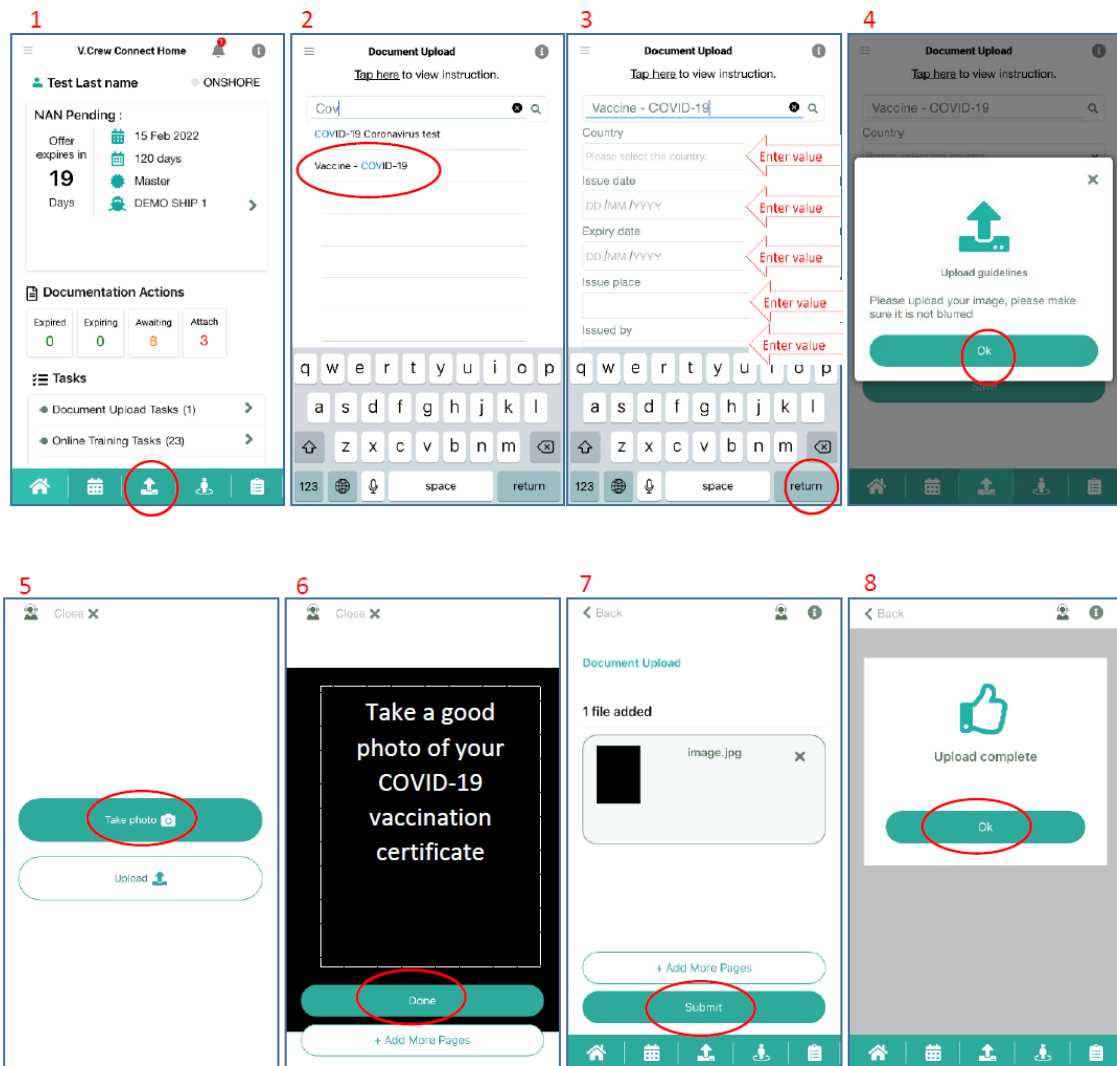
上传您的新冠肺炎注射证明

当您注射完成新冠疫苗后方可进行证书、证明的上传, 所完成剂量或者单剂量 (适用于Jansen疫苗) .

需要第二剂或者补充剂的相关文件请勿上传, 因为这是不需要的

当您登录到“V. Crew Connect” App后请按照以下步骤操作:

1. 单击屏幕底部的Upload图标;
2. 在文档搜索字段中输入“Covid”单词, 并选择“Vaccine-COVID-19”文档
3. 仅在以下单元格中输入相关信息:
 - 3.1. 国籍;
 - 3.2. 签发日期 – 这个请标注您的第二剂针剂日期;
 - 3.3. 签发地点;
4. 当Upload Guidance屏幕出现时, 单击OK;
5. 点击拍照按钮(可以从手机内存中上传文件);
6. 一旦拍摄了照片, 如果疫苗文档有不止一页(例如, 每一剂疫苗都在一个单独的页上), 请单击“完成”或选择“添加更多页”;
7. 点击“提交”按钮;
8. 上传完成后将出现上传完成的消息。单击“OK”返回应用程序主页.
